### **Free School Meals**

We understand that for some of you, your financial circumstances may have changed during the current coronavirus pandemic, which may mean that your child is now eligible for Free School Meals.

**In addition to receiving free school meals when your child returns to school (via an automatic top-up on their payment card) - over the forthcoming summer holiday, the government are providing parents and carers with a £90.00 supermarket voucher for each eligible child, to help with food costs at home.**

Your child may be eligible if you receive ANY of the following:

- Universal Credit - and your household income is less than £7,400 a year (after tax and not including any benefits you get)
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit

During the coronavirus (COVID-19) outbreak, the government are temporarily extending free school meal eligibility to include some children of groups who have no recourse to public funds (NRPF). These groups are:

- children of Zambrano carers
- children of families with no recourse to public funds with a right to remain in the UK on grounds of private and family life under Article 8 of the European Convention on Human Rights
- children of families receiving support under Section 17 of the Children Act 1989 who are also subject to a no recourse to public funds restriction

Unfortunately, the school cannot apply on your behalf; and your details ARE NOT passed over automatically when you apply for any of the above credits and allowances; or if you are part of any of the above groups.

**To apply for free school meals, you just need to complete the attached 2-page form and return it to Leicestershire County Council. You can also download the form directly from:**
